Membership Eligibility and Policies

1. Members of NAGASA agree to abide by the bylaws and policies of the Association.
2. Full membership shall be open to any firms, corporations or division of a corporation engaged in distribution or manufacturing (and importing) for distribution of graphic arts, printing, and imaging products. The NAGASA Board of Directors will determine eligibility for membership based upon requirements contained in the bylaws and policies of the Association.
3. Dues shall be based on a member's sales of equipment, supplies, systems, software, paper and services sold through distribution channel. All sales data strictly confidential.
4. Firms granted membership shall begin such membership for one full year from date of application
5. Membership will remain in force for one full year and thereafter shall be renewed automatically, unless terminated in writing.
6. NAGASA and PESDA, Printing Equipment & Supply Dealers' Association of Canada, operate under joint membership. Canadian firms are required to be members of PESDA and automatically become a NAGASA member. Please complete this membership application, and NAGASA will forward to PESDA.
7. NAGASA dues are not deductible as a charitable contribution for tax purposes, but continue to be deductible as a business expense. Dues are 100% deductible as a business expense since NAGASA does not engage in lobbying.
